Implementation Process




- Develop strategies and identify key activities.

Overall SHIP Progress, December 2022



SHIP Progress by Priority Area, December 2022






Opportunities for Improvement


In 2021,

- **580,000** individuals aged 65 and older live with a diagnosis of Alzheimer's Disease.¹
- 806,000 individuals served as caregivers who provided over 1.3 billion hours of unpaid care for individuals with Alzheimer's Disease.²


In Florida, there are currently **362 geriatricians** and **73,130 home health and personal care aides** who care for individuals with Alzheimer's Disease.³

Current Activities

- Proclamation of November as Family Caregiver Month by Governor Ron DeSantis.
- Updating the Alzheimer's Disease and Related Dementias Resource Guide and Caregiver Toolkit for the general public.
 - Creating sub workgroups to focus on three areas of interest.
- Developing a resource guide for social workers and case managers.
- Promotion of the business designation program to achieve dementia friendly business certification.





Next Steps

- Development of multilingual resource guides and toolkits for health providers, the general public and caregivers.
- Ensuring facilities who have deficient Alzheimer's Disease and Related Dementias training receive the proper support and resources.
- Developing a checklist for caregivers.









In 2021,

- There were **46,889** deaths from cancer.¹
- There were 8,032 deaths from diabetes.²
- There were **50,027** deaths from heart disease.³

Current Activities

- Integration and partnership building at statewide meetings.
- Statewide Colorectal Cancer Screening and Prevention Initiative.
- Recruitment and enrollment for the Heart Health Plus Program and the Florida Stroke Registry.
- Clean Indoor Act Preemption.





Next Steps/Opportunities

- Actively recruit non-traditional partners to serve on the Chronic Diseases and Conditions Priority Area Workgroup (PAW).
- Leveraging local and state resources and funds to develop shared marketing and messaging on health promotion and disease prevention for those living with co-morbidities.
- Convening a meeting of Chairs for various chronic disease related advisory councils to provide recommendations for prevention and management.










In 2021,


- There were 17,654 deaths from unintentional injury.¹
- The sudden unexpected infant death rate of infants (12 months or younger) was 1 per 1,000 births.²
- 22.2% of adults experienced four or more Adverse Childhood Experiences (ACEs), e.g., abuse, violence, etc.³

Current Activities

- Launched Cribs for Kids National Safe Sleep Hospital Certification process among hospitals.
- Developed a partnership between Area Agencies on Aging (AAA) and the Florida Department of Health in support of Safe Mobility, an aging driver initiative.
- Developed a partnership with Florida State University to connect local trafficking service providers, coalitions and CHDs.





Next Steps

- Recruit additional partners with specific knowledge of topic areas based on activity-level work who can provide data that feed up to objective level measures.
- Recruit champions and program representatives who can provide information on current projects (Drug Policy Advisory Council, Safe Kids).
- Develop plan to support two-way communication with health departments and partners in geographic areas of focus for SHIP ISV activities.
- Development of an Adverse Childhood Experiences (ACEs) prevention strategy mapping tool.



In 2021,

- The infant mortality rate was 5.9 per 1,000 live births, compared to the Healthy People 2030 target of 5.0 per 1,000 live births.^{1,2}
- Children with a mental or behavioral health condition who received treatment or counseling was **42.5%**, compared to Healthy People 2030 target of **79.3%**.



Current Activities

- Identification of a Patient-Centered Medical Home (PCMH) for Children with Special Healthcare Needs champion to assist with provider outreach and PCMH accreditation.
- Development of the Shortened Neonatal Abstinence Syndrome (NAS) Infant Length of Stay Transition Plan.
- Implementation of The Florida Perinatal Quality Collaborative's (FPQC) Postpartum Access and Continuity Care (PACC) Initiative to increase Medicaid Postpartum Visits.
- Participation in the Florida Dental Hygienists Association symposium.





Next Steps

- Develop a Learning Action Network model to increase provider access and readiness for Patient-Centered Medical Home (PCMH) transformation.
- Conduct Family Focus groups to identify challenges and barriers that contribute to gaps in access to Pediatric Patient-Centered Medical Homes (PCMH) for parents of Black children and youth with special health care needs.
- Continue to partner with the Florida Dental Association (FDA) and Florida Dental Hygienists Association (FDHA) to provide training and to share information about job opportunities in both the public and private sectors.
- Promote Screening, Brief Intervention and Referral to Treatment (SBRIT) to hospitals and health plans was drafted for implementation in 2023.
- Continue outreach for recruitment of Champions and an additional PAW Co-Chair.






Mental Well-being and Substance Abuse Prevention



In 2021,

- 15.2 percent of adults reported having poor mental health on 14 or more of the past 30 days.¹
- The age-adjusted rate of death by suicide was 13.8 deaths per 100,000 individuals.²
- There were 8,093 drug overdose deaths.³



Current Activities

- Implementation of an educational campaign for hospitals on Screening, Brief Intervention, and Referral Treatment (SBIRT), Medication-Assisted Treatment (MAT) and naloxone.
- Development of suicide data surveillance and analysis plans.
- Promotion of the Florida Pediatric Mental Health Collaborative.
- Implementation of Coordinated Opioid Recovery Network (CORE) program in 12 counties.



Mental Well-being and Substance Abuse Prevention



Next Steps

- Stakeholder collaboration to develop and implement media campaigns.
- Expand CORE to additional counties.
- Initiating workgroup to identify approaches and initiatives for improving efficiency and effectiveness of care coordination.
- Engaging residency programs and medical associations to build capacity.
- Identifying task forces and coalitions for substance use and misuse to support increased distribution of naloxone.

In 2021,

- 11% of Floridians aged 25 years and older did not have a high school diploma.¹
- 22.3% of adults in Florida did not have a medical checkup in the past year, and 12.1% of adults in Florida could not see a doctor in the past year due to cost.²
- 56% of rental housing units rent costed 30% or more than the household income.³



Current Activities

- Working to identify additional partners such as, community-based organizations (CBOs), universities and state-wide workgroups to address education, healthcare and economic vitality.
- Discussion of objectives in need of guidance.





Objectives in Need of Guidance

- SEC2.1 By December 31, 2026, increase the rate of licensed Florida physicians from 314.0 per 100,000 population (2021) to 376.8 per 100,000 population.
- Proposed Objective:
 - By December 31, 2026, increase the number of licensed Florida physicians practicing in a rural county from 15 (2022) to 25.





Objectives in Need of Guidance

- SEC4.3- By June 30, 2026, increase the percentage of qualified dwelling needs met for weatherization assistance from 11% (2021) to 30%.
- SEC4.4- By June 30, 2026, increase the percentage of government loan funds obligated compared to total funds available at the beginning of the reporting period for small business and targeted industries from 19% (2021) to 75%.


In 2021,

- There were 4,708 new diagnosis of Human Immunodeficiency Virus (HIV), and 1,860 new diagnosis of Acquired Immunodeficiency Syndrome (AIDS).¹
- There were **165,817** cases of bacterial STDs.²
- 39.4% of adults received a flu shot in the past year.³

Current Activities

- Developed series of educational presentations on sexually transmitted infections (STIs) targeting adolescents.
- Developed a protocol for the implementation of opt-out rapid syphilis and HIV testing.
- Modified the Sexually Transmitted Disease (STD) and Viral Hepatitis Section's STD Operations and Technical Assistance Manual.
- Developed Ventilator-Associated Events (VAE) toolkit and statewide webinar series.
- GlaxoSmithKline (GSK) evaluating potential organizational alignments with priorities of the PAW.












- Strategically align state and local efforts to better address community needs.

- Foster an environment for innovative thought and engagement among partners.




State Health Improvement Plan Timeline








